

Keeping up with the news: Resources for Contracting Updates

The only constant in government contracting is change. This truth is the theme of APTAC's 2016 Spring Conference. But it is also a challenge with which PTAC counselors must contend every day. Changing laws, changing regulations, changing interpretations, changing processes . . . how can a PTAC counselor possibly keep current?

Adding complexity to this task is the necessity to be mindful of at what point a provision actually becomes effective, as opposed to being merely in the pipeline. It can be confusing for PTAC counselors or clients to hear of proposed legislation or rules – or even new laws that have been passed but for which rulemaking is not yet complete – if they don't fully understand the implementation process. A good case in point is the SBA's Woman-owned small business program. Congress passed the Equity in Contracting for Women Act authorizing set-asides for WOSBs/EDWOSBs in 2000, but rulemaking was delayed and consequently the program was not implemented until 2011. During the interim, the fact that WOSB set-asides were allowed by law was irrelevant because there was no mechanism for achieving them. That being said, because strategies for government contracting often involve planning into the future, it can be helpful to clients to have a heads-up about possible/likely regulatory or programmatic changes in addition to a thorough understanding of the current rules. APTAC remains an invaluable source for PTAC Counselors, providing information on developments in the government contracting arena, but many of our most experienced PTAC professionals find value in following first-hand sources of congressional and agency actions, decisions and proposals. Fortunately, there are a number of government- and private-sponsored sources you can turn to for notice of just such activity. Many thanks to Montana PTAC's Jeff Cuskey (also Co-Chair of APTAC's Body of Knowledge Subcommittee) for sharing the sources <u>he</u> uses to keep on top of the shifting government contracting landscape. Please see his suggestions below (along with a few of our own!)

Some of the resources provide raw, unfiltered information while others reduce and distill the material for their intended audiences. Many busy PTAC professionals would ideally like to receive succinct summaries of changing government laws, regulations and processes. But Jeff notes that there is a potential danger that the authors of summary articles may not have captured all of the pertinent information or may have provided only information that they thought would interest their audience. Reviewing the actual statutory or regulatory language can serve to clarify and deepen understanding of the issue.

Another caution is related to "Google" searches. Many PTAC counselors perform research via "Google" searches, and in the process locate articles written by supposed experts in their professional fields. In a lot of cases, those articles and blogs are written by commercial companies trying to market their services. There is nothing inherently wrong with that. However before using that information as a basis for procurement counseling with a client, Jeff highly recommends that the PTAC counselor conduct independent research on the subject and, if necessary, review the applicable law and regulation to ensure that the information is current and accurate. It would be all too easy to use outdated information from undated articles and blogs only to find out later that the applicable laws and regulations had been changed 5 to 10 years previously.

Finally, especially in light of the complexity noted above, it is essential to remember that as a PTAC Counselor, it is not appropriate for you to provide legal advice to your clients. You can best serve them by making them aware of all of the information pertinent to their situation and allowing them to make decisions about their course of action, seeking additional legal counsel if they see fit.

<u>U.S. Government Accountability Office Email Updates</u>: GAO e-mail updates notify you when publications – including newly issued Comptroller General Decisions - are posted to their Web site.
