# Why is size important?

- Federal procurement: Size qualification for set-aside contracts
- Other situations
  - ✓ SBA Programs/Certifications: 8(a), Women-Owned Small Business (WOSB), HUBZone, SBA Financial Assistance
  - Programs of other agencies patents and licensing
  - ✓ Obtaining federal property

# What is a small business?



- Organized for profit
- Place of business in the U.S.
- And operates primarily in the U.S., <u>or</u> makes a significant contribution to the U.S. economy
- Must meet the size standard for the North American Industrial Classification System (NAICS) code
  - Its size must include all affiliate(s).
- 13 CFR § 121.105 & 13 CFR § 121.201

# **Assigning NAICS Codes**

### For prime contracts

- Determined by procurement agency
- Best describes the principal purpose of the product or service being acquired

### For subcontracts

- Determined by prime contractor
- Reflects product or service being procured in the subcontract

# **NAICS code and Size Standard**

- Each North American Industrial Classification System (NAICS) code has a small business size standard
- Each NAICS code has a monetary-based or employee-based size standard

Wholesale and retail NAICS are not used in government procurements

It's important to recognize that a firm can be small for some NAICS while at the same time be 'other than small' (large) for others.

# **Company X's SAM profile**

Company X is both a small and other than small business -It is small for NAICS codes 334519, 336411, 336413 and 336992 It is large for NAICS codes 488190, 493190, 541330 and 541330

## **How SBA sets Size Standards**

- SBA has exclusive authority to set size standard for each NAICS code
- Rolling reviews every five years
- Adjustments for inflation
- Adjustments for Dept of Census NAICS codes every five years

# Recent Final Rules Increasing Size Standards: Revised Monetary Based Size Standards 87 FR 18607 ; 87 FR 18627; 87 FR 18646; 87 FR 18665 (March 31, 2022)

- SBA issued four final rules to address monetary-based size standards, including all those used in government procurement
- Reviewed 468 size standards
  - 229 increases
  - No decreases because of COVID-19
- 2022 NAICS/Size Standards effective on October 1, 2022.
- Changes apply to new solicitations (or mods before offer at discretion of agency)



## Average Annual Receipts (AAR)

- Use Federal Tax Returns
- "Cost of Goods Sold" plus "Total Income"
- Average of last 5 completed fiscal years for procurements (effective January 6, 2022).

- 13 CFR § 121.104

## Number of Employees

- Count all individuals employed on a full-time, part-time, or other basis
- Average of number of employees for each of the pay periods for the preceding completed **24** calendar months (change from 12 month to 24 months average effective July 6, 2022).

- 13 CFR § 121.106



# **Exclusions**

- Listed in 13 CFR § 121.104(a)
- Inter-affiliate transfers
  - SBA Size Policy Statement No. 3 exclude "all proceeds from transactions between a concern and its affiliates, without limitation"
- Some amounts collected for another as an agent (for example, travel agent)



Receipts or employees of all affiliates

# **Recognizing a small business**

General rule: Contracting Officer "shall" accept self-certification unless there is "a reason to question" the firm's self-certification.

### SAM self-certification

- Must be updated every 12 months
- Effective at time of offer
- Can use "Version" field to look up size for previous certifications

SAM contains a size representation for every company, for every NAICS code. Click on "**View More**" at bottom of the company's size table.

# **Manufacturing Contracts**

On a small business set-aside contract, the offeror must either be the manufacturer or meet the requirements of the Non-Manufacturer Rule

- 13 CFR § 121.406

- Non-Manufacturer Rule does not apply to subcontracts

# Non-Manufacturer Rule (NMR)

- ☐ If the contract is over the Simplified Acquisition Threshold (currently \$250,000), a small business <u>must:</u>
  - (i) have less than 500 employees;
  - (ii) be primarily engaged in the retail or wholesale trade and normally sells the type of item being supplied;
  - (iii) take ownership or possession of the item(s) with its personnel, equipment or facilities in a manner consistent with industry practice; and
  - (iv) supply the end item of a small business manufacturer made in the United States OR obtain a waiver of such requirement...

- 13 CFR §121.406(b)(1)

Non-Manufacturer Rule Waivers may be either class or individual and must be in place before receipt of offers. Procedures are contained in 13 CFR § 121.1204.

# AFFILIATION

# The Key to Size is Affiliation

A concern's size always includes the size of all of its domestic and foreign affiliates

- 13 CFR §121.103(a)(6)

- Two types of affiliation -
  - General Affiliation On-going basis
  - Procurement Only Applies only to the specific procurement

## The Key to Affiliation is Control

Concerns are affiliated...if one concern controls or has the power to control the other, or a third party has the power to control both."

- 13 CFR §121.103(a)(1)

# How does control arise?

- SBA considers many factors when deciding whether control exists:
  - stock ownership
  - stock options and convertible securities
  - agreements to merge
  - common management
  - identity of interest
  - economic dependence
  - ✓ previous relationships or ties (e.g., spin-offs)
  - franchises/licenses and joint ventures
  - ✓ ostensible subcontracting
  - negative control
  - potential control (need not be actual)
    *et cetera*

### - 13 CFR §121.103

# Is a Teaming Agreement a Prime/Sub Relationship or a Joint Venture?





# Prime / Sub Relationship

A potential prime contractor agrees with one or more other companies to have them act as its subcontractors under a specified Government contract



# **Small Business Joint Ventures (JV)**

- JV must be in writing and registered in SAM
- Organized for a specific and limited purpose



Each JV member must qualify as small for the NAICS code assigned to the procurement (exception for SBA-approved mentor-protégé JVs)

- 13 CFR § 121.103(h)

# **Mentor-Protégé JVs**

An SBA-approved mentor and protégé may bid on a federal procurement as an SBC if the protégé is small....

- 13 CFR §121.103(h)(ii)

- SBA must:
  - approve mentor-protégé agreements <u>before offer</u>
  - approve JV agreement before award for 8(a) sole source awards only
  - For other types of procurements, the joint venture agreement may be examined in a size or status protest

# **Ostensible Subcontracting**

- A subcontractor is an ostensible subcontractor if:
  - ✓ is not a similarly situated entity
  - ✓ The subcontractor performs the primary and vital requirements, <u>or</u>
  - ✓ The prime contractor is **unduly reliant** upon the subcontractor
- An ostensible subcontractor will be treated as a joint venture.

- 13 CFR § 121.103(h)(2)

# **SIZE PROTESTS**

#### What is a size protest?

- A size protest is a challenge to a proposed awardee's size.
- Likely receive size protests for set-aside procurements, i.e., Small Business Set-Aside, HUBZone Small Business setaside, Service-Disabled Veteran-Owned Small Business set-aside, etc.
- If SBA determines that the prospective awardee is not a small business, it can lose the award.



## Who may file a size protest?

For set-aside procurements (including partial set-aside) –

- Any offeror that the contracting officer has not eliminated from consideration for any procurement related reason, such as non-responsiveness, technical unacceptability or outside of the competitive range;
- The contracting officer;
- The SBA Officials
  - The Area Director;
  - The Director for Office of Government Contracting,
  - The Associate General Counsel for Procurement Law
- Other interested parties. Other interested parties include large businesses where only one concern submitted an offer for the specific procurement in question.

- 13 CFR § 121.1001(a)(1)

## Who may file a size protest?

#### For competitive 8(a) contracts-

Any offeror that the contracting officer has not eliminated from consideration for any procurement-related reason, such as nonresponsiveness, technical unacceptability or outside of the competitive range;

The contracting officer;

- The SBA Officials
  - ✓ The SBA District Director, or designee;
  - The Associate Administrator for Business Development,
  - The Associate General Counsel for Procurement Law

- 13 CFR § 121.1001(a) (2)

## Who may file a size protest?

For Subcontracting Program –

- The prime contractor;
- The contracting officer;
- Other potential subcontractors;
- The SBA Officials
  - The Area Director;
  - The Director for Office of Government Contracting,
  - The Associate General Counsel for Procurement Law
- Other interested parties.

-13 CFR § 121.1001(a)(3)



#### When can agency receive size protests?



#### Anytime!!

More likely within ...

5 working days after CO sending out pre-award notifications.

or

5 working days after award notifications being posted on SAM.gov.

or

5 working days after bid openings.

## Which Size Protests Must be Sent to SBA? ALL OF THEM

- Protests must be filed with CO, not SBA.
- COs must forward all size protests to SBA.
- COs/agencies do not have the legal authority to:
  - decide a size protest;
  - ignore a size protest;
  - advise the protester to modify, change, or resubmit the protest.

- 13 CFR §121.1006(a); FAR §19.302(c)(1)

## Which office do you sent your size protest to?

**ALWAYS** send your size protests to:

SBA **Area Office** that has jurisdiction over state in which HQ of protested concern is located.

DO NOT send your size protests to:

- ✓ SBA District Offices
- ✓ SBA Regional Offices
- 🗸 🛛 SBA HQ

#### **Status of Award During Protest**

May not make award for at least 15 business days (until SBA issues its formal determination) unless CO "determines in writing that an award must be made to protect the public interest."

- 13 CFR §121.1009(a)(2); FAR §19.302(g)(1)

CO can award after 15 days—even if SBA's size determination is not finished—by making a formal finding "in writing that there is an <u>immediate need</u> to award the contract and that waiting...will be disadvantageous to the Government."



- 13 CFR §121.1009(a)(3); FAR §19.302(g)(2)

## When sending a size protest to SBA...

CO's referral letter must include the following information to allow SBA to determine timeliness and standing:

- The protest and any accompanying materials.
- A copy of the size self-certification.
- Identification of the applicable size standard.
- A copy or an electronic link to the solicitation and any amendments.
- The name, address, telephone number, email address of the contracting officer.
- Identification of the bid opening date or the date of notification provided to unsuccessful offerors.
- The date the contracting officer received the protest.
- A complete address and point of contact for the protested concern and the protestor.
- CO shall inform SBA if there is also a GAO protest

- 13 CFR § 121.1006(b); FAR § 19.302(c)(3)

#### **Processing a Size Protest**

- If timely and specific, SBA (not CO) will notify the protested concern; firm has 3 business days to respond.
- SBA has 15 business days to render its determination—assuming there is no extension.

- 13 CFR §121.1009(a)

Copy of final determination will be sent to the protester, the protested concern, and the CO.

#### "Other than Small" Determinations

- UNLESS determination was contract specific, companies that were found to be "other than small":
  - Are prohibited from self-certifying as small on any procurement with the same or a lower size standard
  - Must be recertified as small by SBA before self-certifying as small again or OHA reverses the determination;
  - Must notify contracting officers with pending procurements;
  - Must amend their size status in SAM.gov or its successor databases within 2 days after final other than small size determinations.

## Office of Hearings and Appeals (OHA)

- Any person adversely affected by a size determination can appeal to OHA
- Contracting Officer can also appeal
- File within **15 calendar days** after receipt of the size determination
- Judge shall issue a size appeal decision, in so far as practicable, within
   <u>60 calendar days</u> after close of the record.



## Things to keep in mind when filing a size protest

- Protests must be in connection with a "particular" (i.e., pending) procurement
- Protester must have standing to protest or will be dismissed
- In order to affect a specific solicitation, a protest must be timely.
- Date of debrief is irrelevant for protest purposes
- Size protests cannot be used to vet potential awardees
- Premature protests (i.e., before notification of successful offeror) will be dismissed, even if made by CO

# Things to keep in mind when filing a size protest

A protest must contain "specific, detailed evidence to support the allegation that the offeror is not small."

Example 1: Concern X is large because it employs more than 500 employees (where 500 employees is the applicable size standard); this is non-specific.

Example 2: Concern X is affiliated with concern Y without providing any basis for why X and Y are affiliated; this is non-specific.

Example 3: Concern X is affiliated with concern Y because Mr. A is the majority shareholder in both concerns; this is sufficiently specific.

- 13 CFR §121.1007; FAR §19.302(c)(2)
